In regard to the security services RFP (RFP# 06142022 –01), can you inform if the scope of work is for regularly scheduled hours weekly or if it is all as needed? If you could inform the estimated budget and/or the previous usage annually that would be splendid.

Services will be rendered during regular school hours. Special events and after-school activities will be as needed.

- 1. I. Background KMPS includes 4 schools (2 buildings) and serves approximately 2000 students and 200 staff.
- Q1. Are there any special needs or considerations with regards to students and their present academic situations that require visibility or understanding?

We asked that officers are trained to respectfully serve our students and staff. There are no specific needs or considerations to lift.

Services to be Provided Armed and/or Unarmed Guard Service: Vendor will provide armed and/or unarmed security guard service available on an as-needed basis to patrol and monitor facilities before, during, and after school and business hours, overnight/weekend, and during school events, such as sporting events, parent conferences, community outreach, and graduation ceremonies.
- Q1. Is the expectation that all Security specialists have the capability to operate as both armed and unarmed depending on their assignment?
